EXHIBIT "A" LEGAL DESCRIPTION

Part of the SW ¼ of the SW ¼ of Section 34, Township 19 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows: From an existing 2" rebar, being the locally; accepted Northwest corner of said SW ¼ of SW ¼ run in a Southerly direction along the West line of said ¼ - ¼ Section for a measure distance of 79.46 feet to an existing open top iron pin, being the point of beginning; thence turn an angle to the left of 40°08' and run in a Southeasterly direction for a distance of 492.43 feet to an existing P.K. nail being on the Northwest Right-of-way line of Shelby County Highway # 39; thence turn an angle to the right of 77°-31'-13" and run in a Southwesterly direction for a distance of 125.28 feet to an existing iron rebar set by Laurence D. Weygand; thence turn an angle to the right of 93°-44'-58" and run in a Northwesterly direction for a distance of 163.82 feet to an existing iron rebar set by Laurence D. Weygand; thence turn an angle to the left of 32°-54'-28" and run in a Westerly direction for distance of 119.21 feet to an existing iron rebar set by Laurence D. Weygand and being on the West line of said SW ¼ of SW ¼; thence turn an angle to the right of 81°-46'-24" and run in a Northerly direction along the West line of said ¼ - ¼ Section for a distance of 351.16 feet, more or less, to the point of beginning.
