PARTIAL RELEASE OF LIEN

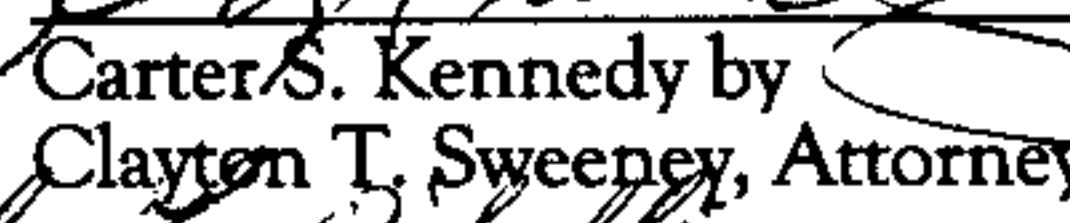

Shelby County, Alabama.

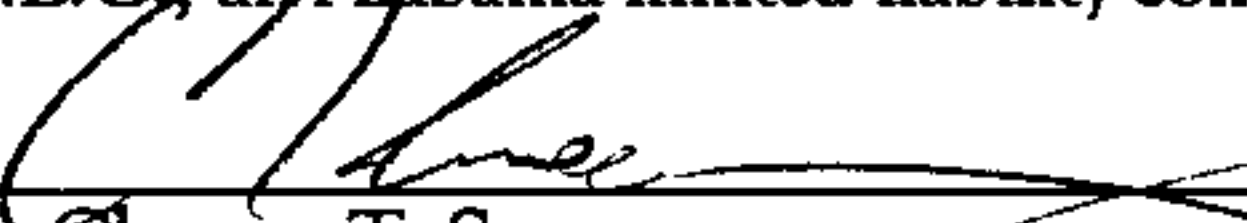

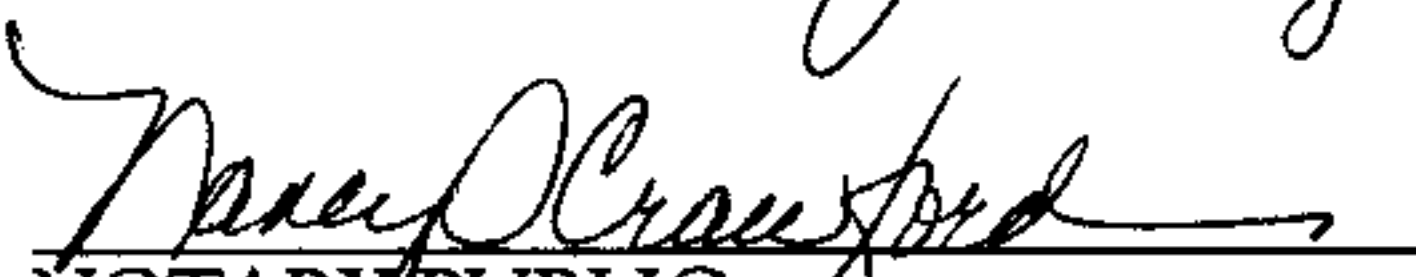
