**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of the sum of Three Hundred Twenty-Two Thousand Four Hundred and no/100 Dollars (\$322,400.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **NEWCASTLE CONSTRUCTION, INC** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **DAVID R. WILLIAMS and JAMIE L. WILLIAMS**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 2, according to the Survey of The Woodlands, Sector 1, as recorded in Map Book 27, Page 63, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2002 and subsequent years not yet due and payable.


