## **Subordination Agreement**

THIS AGREEMENT is made and entered into on this 18 day of January 2002, by AmSouth Bank(hereinafter referred to as "AmSouth") in favor of ,its successors and assign (hereinafter referred to as "Lender").

## RECITALS

AmSouth loaned to Steven M. Milliron & Kristine Milliron (the "Borrower", whether one or more) the sum of \$13,000.
