**ARTICLES OF ORGANIZATION  
OF  
TWO ROADS, L.L.C.**

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1.     **NAME:**           The name of the Limited Liability Company is Two Roads, L. L. C.

2.     **DURATION:** The existence of the Limited Liability Company known as Two Roads shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall be perpetual; provided, however, that the Limited Liability Company shall be dissolved upon the earlier of:

- (a)    the written consent of all the members:
- (b)    the occurrence of such events as are specified in the Operating Agreement;
- (c)    the occurrence of such events as are specified by the Alabama Limited Liability Company Act.

3.     **PURPOSES:** The purpose for which this Limited Liability Company known as Two Roads is organized is to engage in the transaction of any or all lawful businesses for which limited liability companies may be organized under the laws of the State of Alabama, including but not limited to acquiring, owning, selling, leasing and otherwise transacting in real or personal property, wherever situated and specifically including but not limited to construction and operation of a golf supplies shop. The Limited Liability Company shall have all the powers vested in a limited liability company in accordance with the Alabama Limited Liability Company Act and the laws of the State of Alabama.

4.     **REGISTERED OFFICE AND AGENT FOR SERVICE OF PROCESS:**  
The location of the initial registered office shall be: 140 Kings Crest Lane, Pelham, Alabama, 35124. The name of the initial registered agent for service of process at said address shall be Robert A. Thompson.

6. **ADDITIONAL MEMBERS:** The Limited Liability Company known as Two Roads shall admit additional members to the Limited Liability Company only upon the consent of the Initial Member along with the consent of any members who might own a majority of the percentage interests in the Limited Liability Company at any future date.

7. **CONTINUITY OF BUSINESS:** The legal existence and business of the Limited Liability Company known as Two Roads shall continue after an event causing a cessation of a member's interest in the Limited Liability Company, to the extent allowed by the Alabama Limited Liability Company Act.

8. **MANAGEMENT:** The Limited Liability Company known as Two Roads shall be managed by one Manager who shall serve as manager until the first annual meeting of the member(s) of the Limited Liability Company or until successor(s) are elected and begin serving.
