Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.

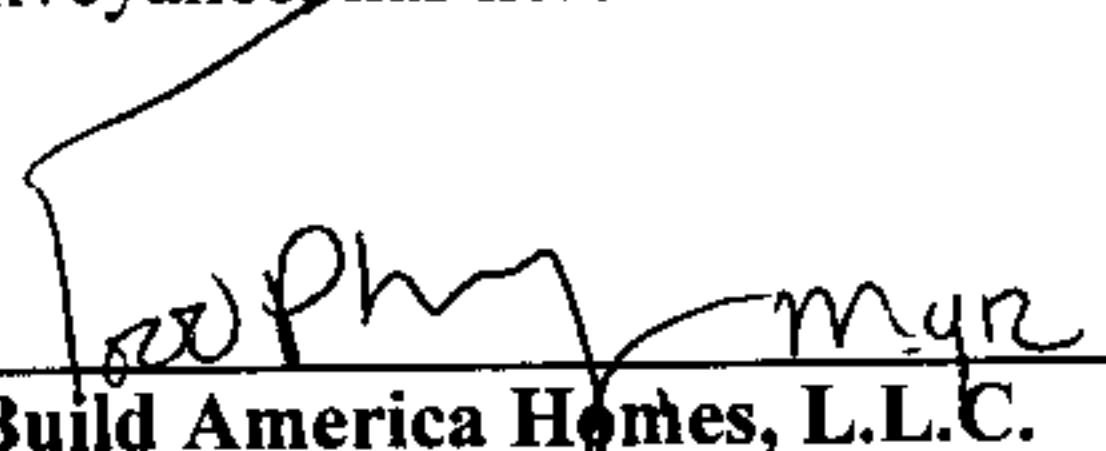
\$203,900.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

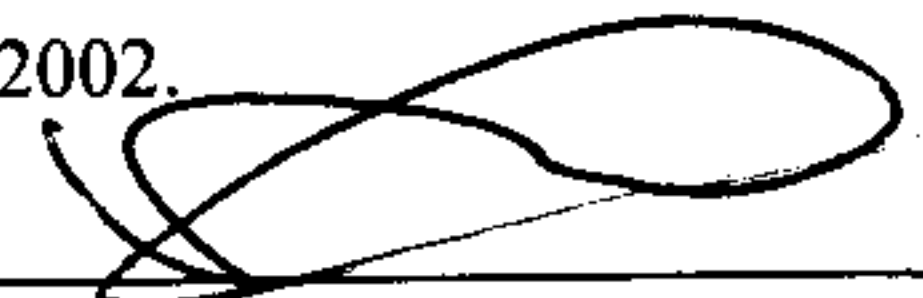
