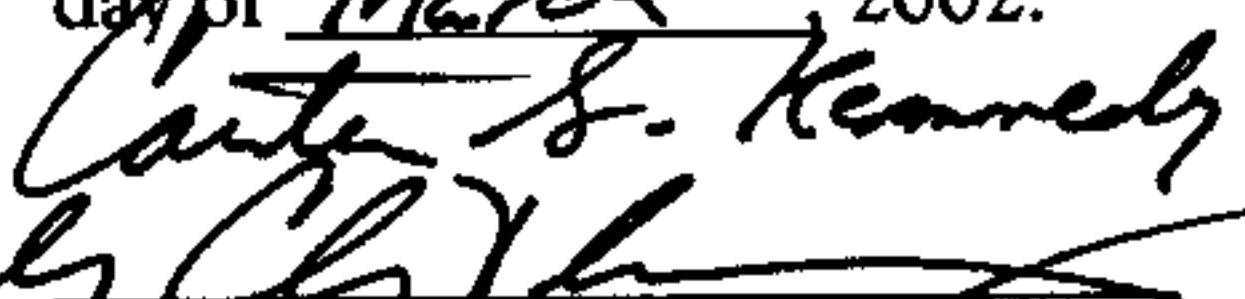
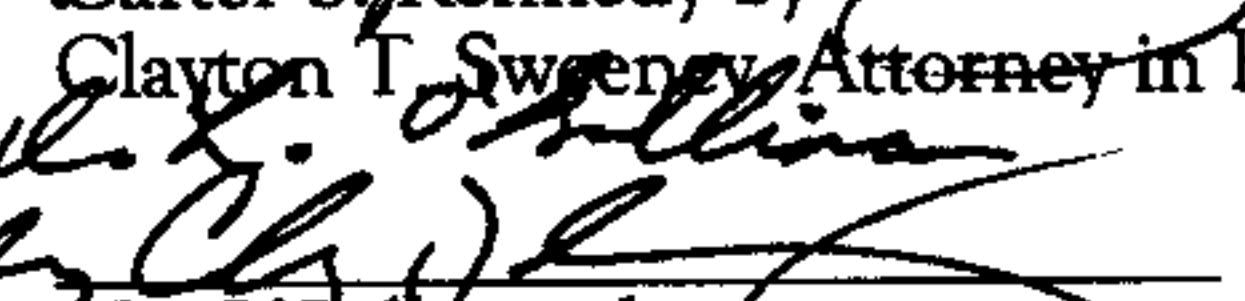
PARTIAL RELEASE OF LIEN

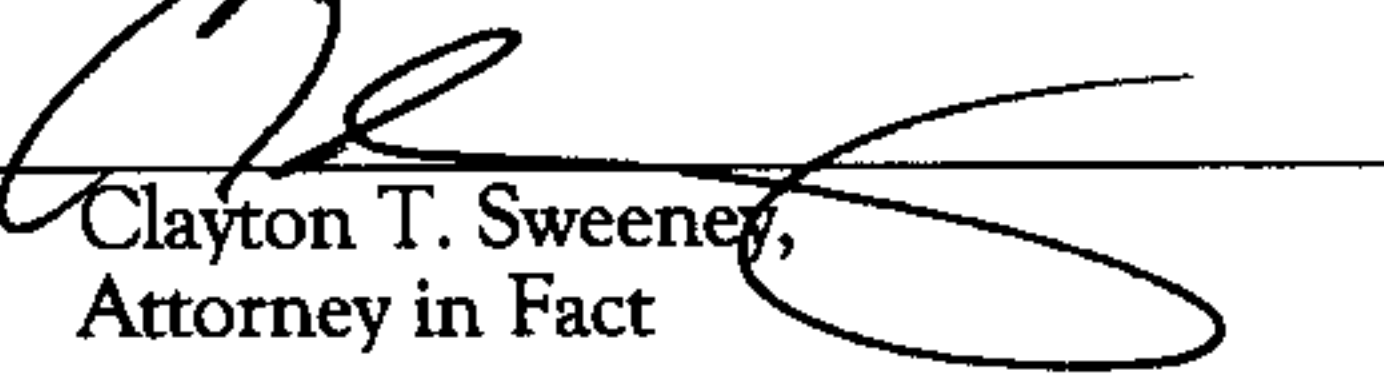
Lot 637, according to the Survey of Forest Parks, 6th Sector, 2nd Phase
