Thereupon, the Mayor declared said motion carried and unanimous consent given for the consideration of said Resolution.

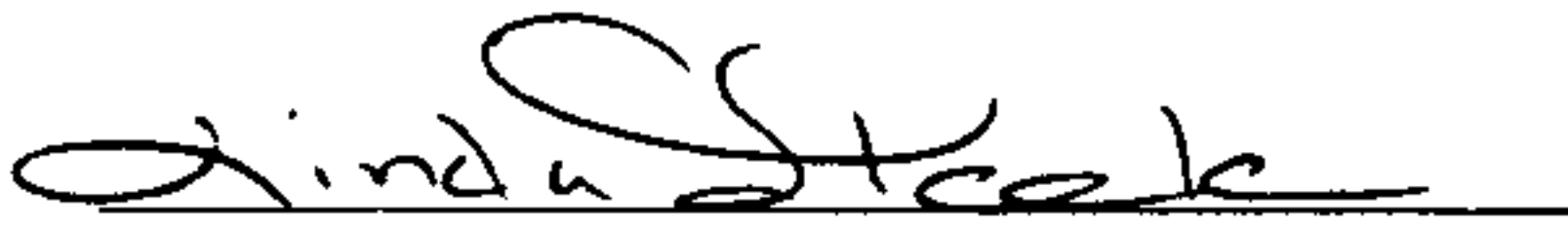
Council Member Phillips moved that Resolution No. R-2002-03 be adopted. Council Member Glasgow seconded said motion and upon vote, the results were as follows:

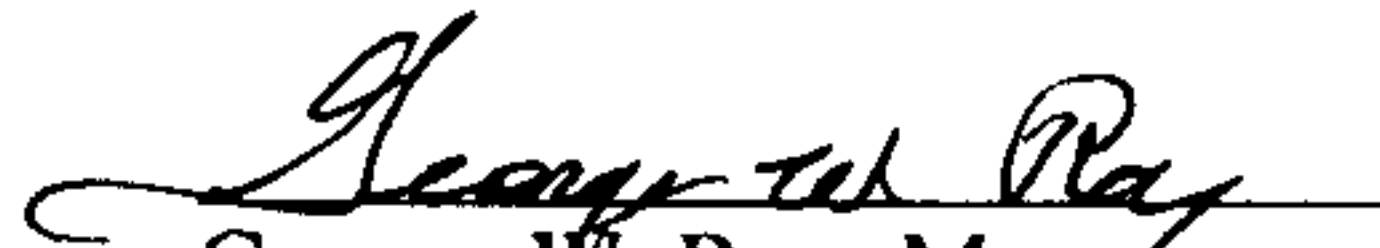

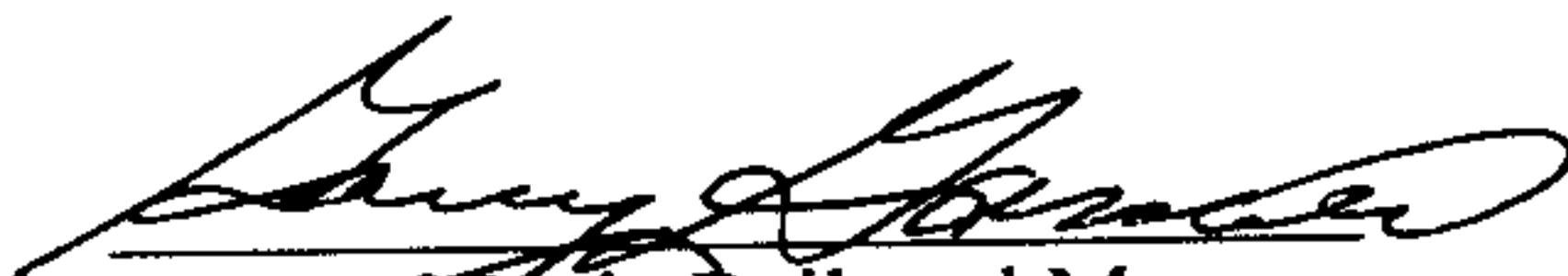
REQUEST TO VACATE STREET

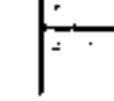
COUNTY LOCATOR



TOWNSHIP LOCATOR



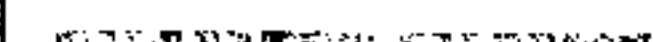

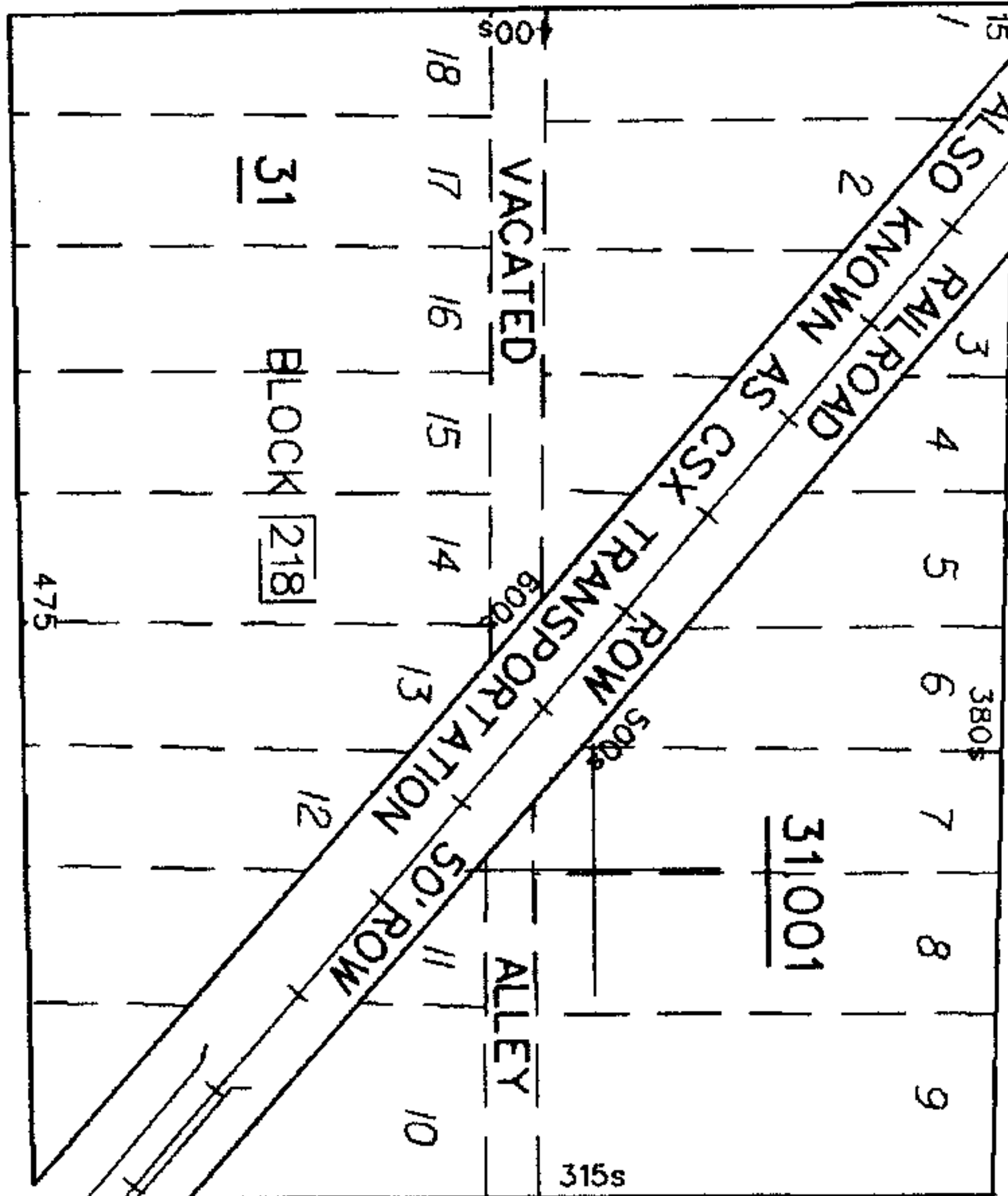

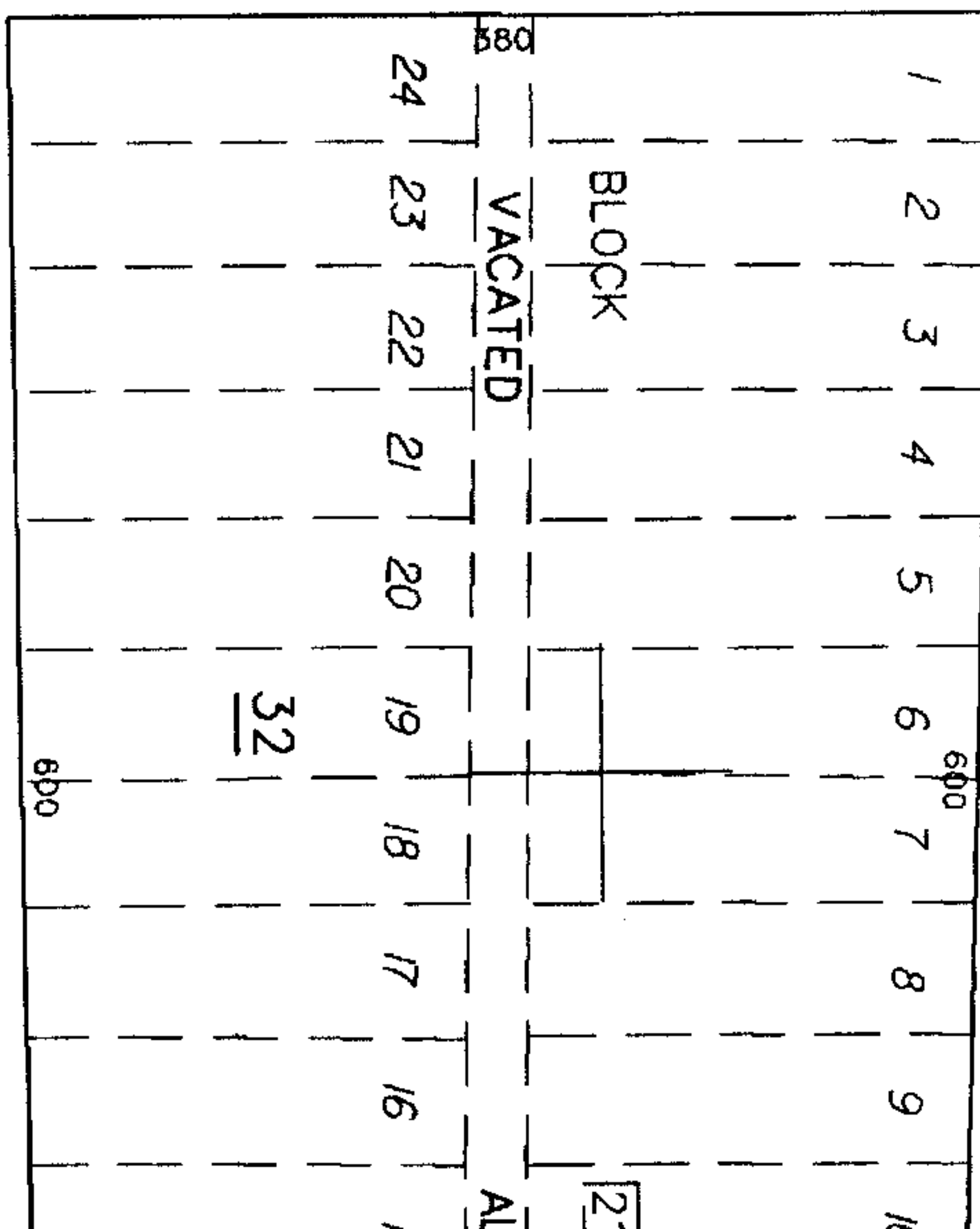
