Alabama.

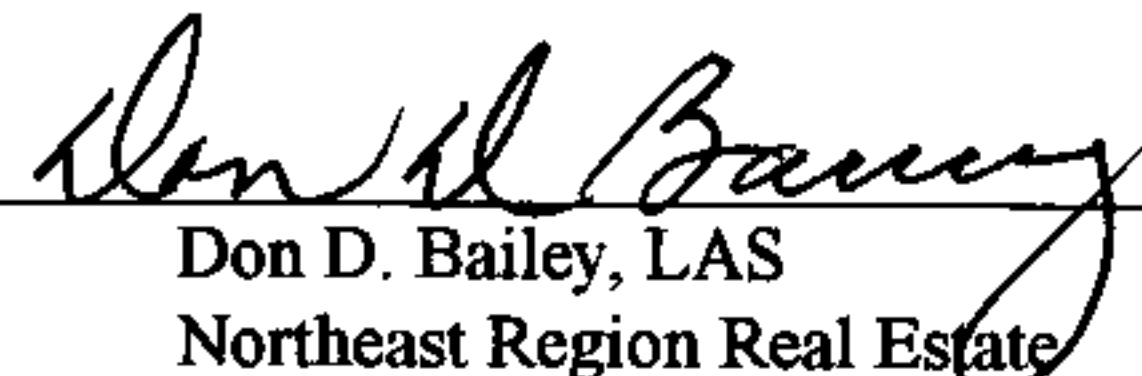

A parcel of land situated in the north half of Section 31, Township 19 South, Range 2 West, Shelby County, Alabama being more particularly described as follows:
