**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of the sum of Two Hundred Seven Thousand One Hundred Ninety-Nine and no/100 Dollars (\$207,199.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **TAMBRIDGE BUILDING CO., INC** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **PHILIP A. MOUTARDIER and TRISA M. MOUTARDIER**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 406, according to the Survey of Lake Forest, Sector 4, as recorded in Map Book 28, Page 93, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2002 and subsequent years not yet due and payable.

\$186,450.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.


