YOUR PETITIONER, Patricia Ann Morrison-Bolian, hereinafter referred to as Petitioner, respectfully represents unto your Honor that Jonnie H. Morrison, hereinafter referred to as Decedent, who was, at the time of death, an inhabitant of this County, departed this life in Madison County, Alabama, on or about July 13, 2001, leaving assets in this State, and leaving a Last Will and Testament duly signed and published by said Decedent and attested by Stacye D. 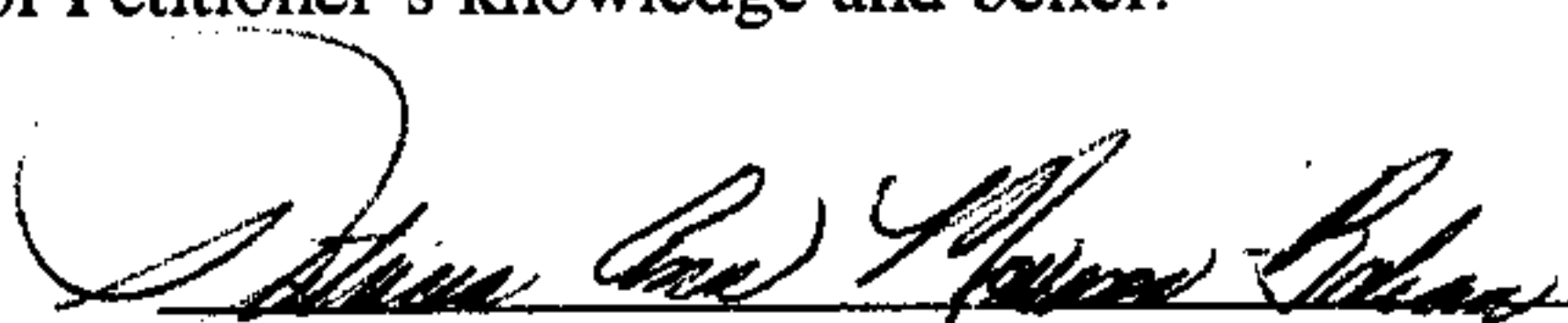

I, **Jonnie H. Morrison**, a resident of the County of Madison, State of Alabama, being of sound mind and disposing memory and above the age of nineteen years, do hereby make, publish and declare this as my Last Will and Testament, herein disposing of all of my property of every kind, both real and personal, which I own or may be entitled to possess at my death or have the right to dispose of by Will, hereby revoking any and all other Wills and Codicils heretofore made by me at any time.

As used in this Will, the pronouns "he", "him" and/or "his", when used to refer to the Executor, or alternate, Personal Representative, or alternate, named herein, shall apply to any entity acting in such capacity, whether the same is male or female or whether the same is institutional, organizational or corporate in nature. The term "Executor" shall apply whether such entity is male, female, institutional, organizational, corporate, singular or plural.

FIRST ITEM: At my death, I do hereby nominate, constitute and appoint my daughter, **Patricia Ann Morrison-Bolian**, as the Executor of this my Last Will and Testament, and I hereby expressly waive and exempt said Executor from the necessity of filing any inventory of my estate in any Court and from making any final settlement of my estate in any Court, and I direct that my Executor shall be exempt from giving official bond. In the event my said Executor predeceases me, or in the event said Executor should be unable or unwilling to serve in such capacity, then I appoint my son, **Gerold Michael Morrison**, as my first alternate Executor, or in the event he should be unable or unwilling to serve in such capacity, then I appoint my son, **Robert Guy Morrison**, as my second alternate Executor, to serve in said capacity, and stand under the same terms and conditions set forth above. Any and all references to my Executor shall apply to any alternate Executor named herein.

SECOND ITEM: I direct that all my lawful debts, including those incurred during my last illness, my funeral expenses, the cost of the administration of my estate, and inheritance, estate or other death taxes that may be imposed upon my estate, including interest and penalties thereon, be paid by my Executor as soon as possible after my death. My Executor shall not, however, be required to pay prior to maturity, any debt, secured or unsecured, on property owned by me at the time of my death, and such property may pass, at the option of the Executor, subject to such debt. My Executor shall not require any

beneficiary under this Will to reimburse my estate for taxes paid on property passing under this Will.

THIRD ITEM: At my death I hereby give, devise and bequeath all of my estate, both real and personal, wheresoever situated, as follows:

a. Unto my son, Gerold Michael Morrison, all of my right, title and interest in and to a residential house and lot located at 305 Homewood Drive, S.W., Huntsville, Alabama, in absolute fee simple. If this property is sold before my death, I bequeath to Gerold Michael Morrison a sum of money equal to the net sale proceeds of such sale, subject to the conditions set out below.

b. Unto my daughter, Patricia Ann Morrison-Bolian, all of my right, title and interest in and to my real estate located in Shelby County, Alabama on Old Highway 280, as described in Deed Book 285, Page 473 by deed recorded on February 26, 1974, consisting of approximately 25 acres of undeveloped land, in absolute fee simple. If this property is sold before my death, I bequeath to Patricia Ann Morrison-Bolian a sum of money equal to the net sale proceeds of such sale, subject to the conditions set out below.

c. Previously my son, Robert Guy Morrison, has received an advancement from me by the conveyance of real estate located in Shelby County, Alabama, to him.

d. Unto my children, Robert Guy Morrison, Patricia Ann Morrison-Bolian and Gerold Michael Morrison, all of the rest and residue of my estate, both real and personal, wheresoever situated, in equal shares, share and share alike, in absolute fee simple, per stirpes and not per capita.

e. In the event of the sale of my home located at 305 Homewood Drive, S.W., Huntsville, Alabama, and/or my real estate located in Shelby County, Alabama, on Old Highway 280 before my death as set out above, it is my desire that the net proceeds from such sale or sales be segregated and remain assets of my estate for distribution as set out in paragraphs a. and b. above. It is my desire that my other assets be depleted before such funds are used for my benefit. If my other assets are depleted and it becomes necessary to use a portion of such funds for my benefit, then it is my desire that such funds and/or the value of such specific devise to Gerold Michael Morrison and Patricia Ann Morrison-Bolian be reduced proportionately.

transfer and conveyance as fully and effectually as I might or could do in my lifetime, and I expressly release any and all purchasers of my said Executor from the responsibility of looking to the application of the purchase price. My Executor's deed, bill of sale or other transfer instrument shall be sufficient in all matters to convey to the purchasers full title thereto.

Morrison**, the Testatrix, sign my name to this instrument, and being first duly sworn, do hereby declare to the undersigned authority (1) that I sign and execute this instrument as my Last Will and Testament, (2) that I sign it willingly (or willingly direct another to sign for me), (3) that I execute it as my free and voluntary act for the purposes therein expressed, and (4) that I am nineteen years of age, or older, of sound mind, and under no constraint or undue influence on the 12th day of December, 1997.

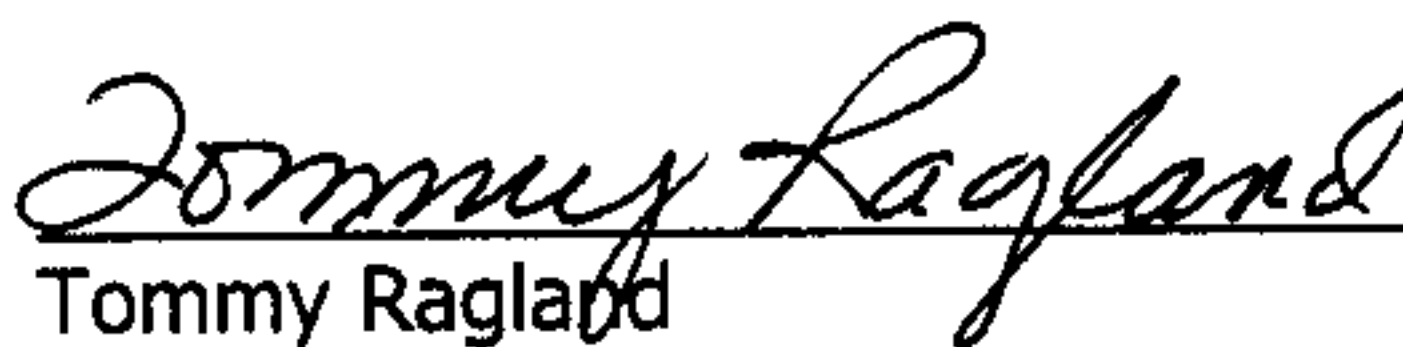

DECREE FOR SELF-PROVING WILL

THE PETITIONER, Patricia Ann Morrison-Bolian, hereinafter referred to as Petitioner, filed a verified Petition showing unto the Court that the Decedent, Jonnie H. Morrison, who was, at the time of death, an inhabitant of this County, departed this life in Madison County, Alabama, on July 13, 2001, leaving a Last Will and Testament, duly signed and published on December 12, 1997, by said Decedent, and attested by Stacey D. Lester and Patty Hanson, who are residents of Madison County, Alabama, and notarized by Myra Holly Chittiam, a duly authorized Notary Public in and for the State of Alabama at Large, and that Petitioner is named in said Will as Executor thereof.

The Petitioner surrendered said Will to the Court to be probated and recorded as the true Last Will and Testament of said Decedent.

It appears to the Court, from said Petition, that **Robert Guy Morrison, Patricia Ann Morrison-Bolian and Gerold Michael Morrison** are all of the heirs at law and next of kin of said Decedent, and that they are all over the age of nineteen (19) years and of sound mind.

It further appears to the Court that said Will was executed by the Decedent before two (2) subscribing witnesses on December 12, 1997, at Huntsville, Madison County, Alabama. It also appears to the Court that the Testatrix acknowledged before a notary public that said Will was executed under her own free will as and for her Last Will and Testament, and that the two (2) subscribing witnesses subscribed and were sworn and acknowledged before a notary public that they both executed the Will as witnesses to the signature of the Testatrix.

This Court further finds that the execution of this Will by the Testatrix and the two (2) witnesses, all signatures having been notarized by a notary public for the State of Alabama at Large, substantially conforms to Ala.Code § 43-8-132 (1975), et seq., which provides for "self-proving" Wills.

Now therefore, upon consideration of the Petition, and of the fact that the Will offered as the Last Will and Testament of Jonnie H. Morrison, Deceased, is in substantial conformity with the provisions of Ala.Code § 43-8-132 (1975), et seq., it appears to the Court that the facts alleged herein are true and that said Will was duly and properly executed by said Decedent. It is therefore,

ORDERED, ADJUDGED AND DECREED BY THE COURT that the prayer of said Petition be and the same is hereby granted and the instrument of writing so filed in this Court by the Petitioner herein attested by Stacye D. Lester and Patty Hanson, notarized by Myra, Holly Chittiam, and dated December 12, 1997, which instrument is purported to be the Last Will and Testament of said Decedent, be and the same is hereby duly probated and admitted to record as the true and Last Will and Testament of said Decedent.

It further appearing to the Court from said Will, that said Decedent has named the Petitioner as Executor, without bond, and the said named person being a suitable person to act in such capacity, and no cause being shown requiring bond, it is therefore;

ORDERED that Letters Testamentary upon the Will of Jonnie H. Morrison, Deceased, be granted and issued forthwith to said Petitioner, naming Petitioner as the Personal Representative of said estate, which is accordingly done. It is further,

ORDERED by this Court that the said Personal Representative shall have all the powers and duties provided in the Will, and all the general powers, authorized for transactions as enumerated in Ala.Code § 43-2-843 (1975, as amended). It is further,

ORDERED that the said Personal Representative, in addition to the general powers and duties granted, specifically is authorized, with prior Court approval, to act in transactions enumerated in Ala.Code § 43-2-844 (1975, as amended), unless otherwise provided in said Will. It is further

ORDERED by the Court that the aforesaid limitations, if any, be prominently endorsed upon the face of the Letters Testamentary when issued.

It is further ordered that said Personal Representative proceed without delay to collect and take into possession, or control, all of the personal property and evidences of the property of the Decedent. It is further,

ORDERED, that, after six (6) months from the appointment of the Personal Representative, said Personal Representative must render an exhibit under oath, showing the amount of all claims presented against the estate, and the names of the claimants, and all other matters necessary to show the condition of its affairs. It is further,

ORDERED that said Petition, Letters and all proceedings herein be recorded.

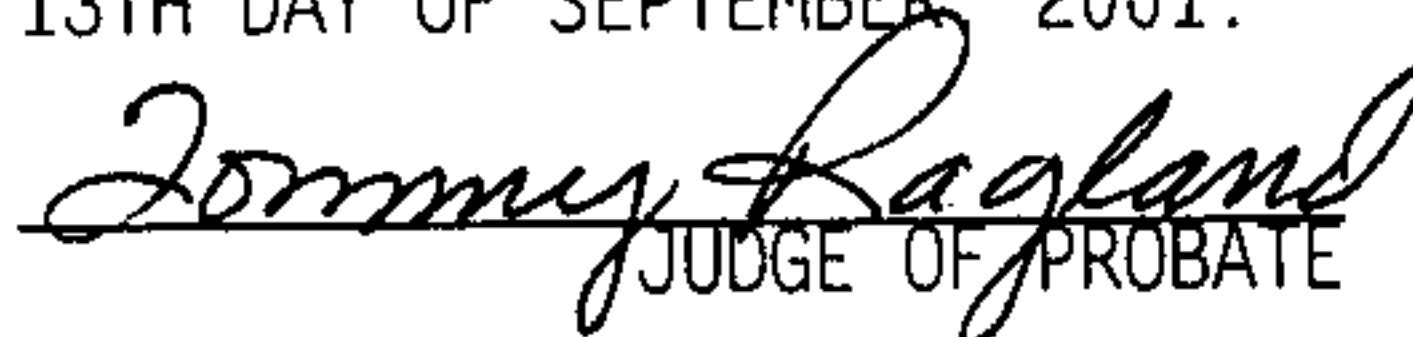

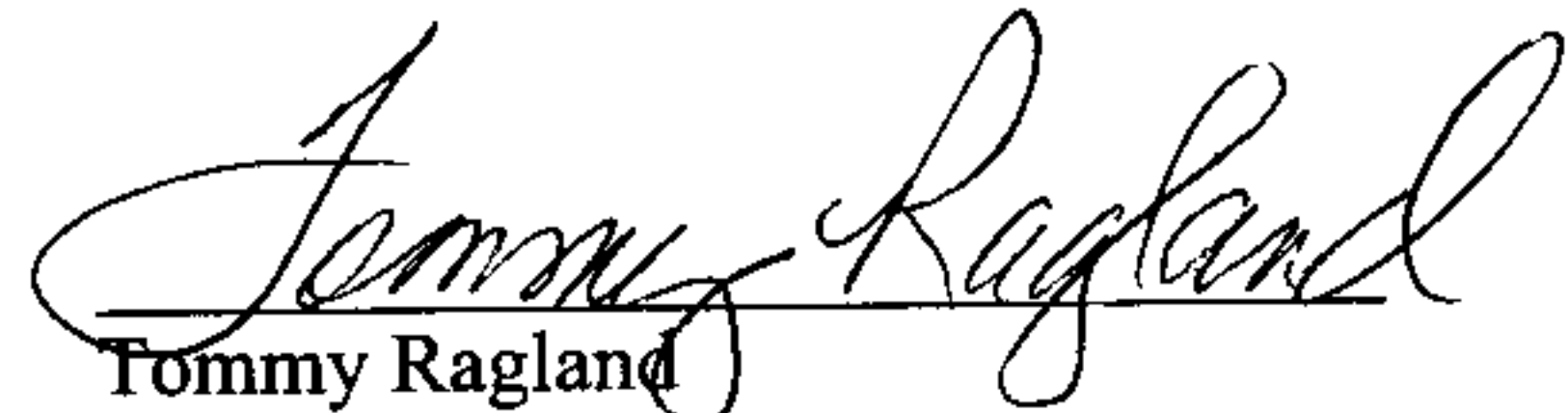
