DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, which are intended to constitute a Durable Power of Attorney, that I, **Estelle Jeanette S. Allen**, of Shelby County, State of Alabama, the undersigned, **DO HEREBY MAKE, CONSTITUTE AND APPOINT Jane Vick**, of Shelby County, State of Alabama, my true and lawful Attorney in Fact, for me and in my name, place and stead, and on my behalf and for my use and benefit, to do, perform and execute all and every act that I may legally do through an attorney in fact, and every proper power necessary to carry out the purposes for which this power is granted, with full power of substitution and revocation, hereby ratifying and affirming that which the said **Jane Vick** or her substitute shall lawfully do or cause to be done by herself or her substitute lawfully designated by virtue of the power hereby conferred upon her.

The rights, powers and authority of my said Attorney in Fact herein granted shall commence upon the execution of this instrument and shall be in full force and effect upon execution of this instrument; the authority herein conferred shall not be affected by disability, incompetency, or incapacity of said principal, **Estelle Jeanette S. Allen**; and such right, powers and authority shall remain in full force and effect until the death of the principal **Estelle Jeanette S. Allen**. Any action taken in good faith pursuant to the foregoing authority without actual knowledge of my death shall be binding upon me, my heirs, assigns, and personal representatives.


