PARTIAL RELEASE

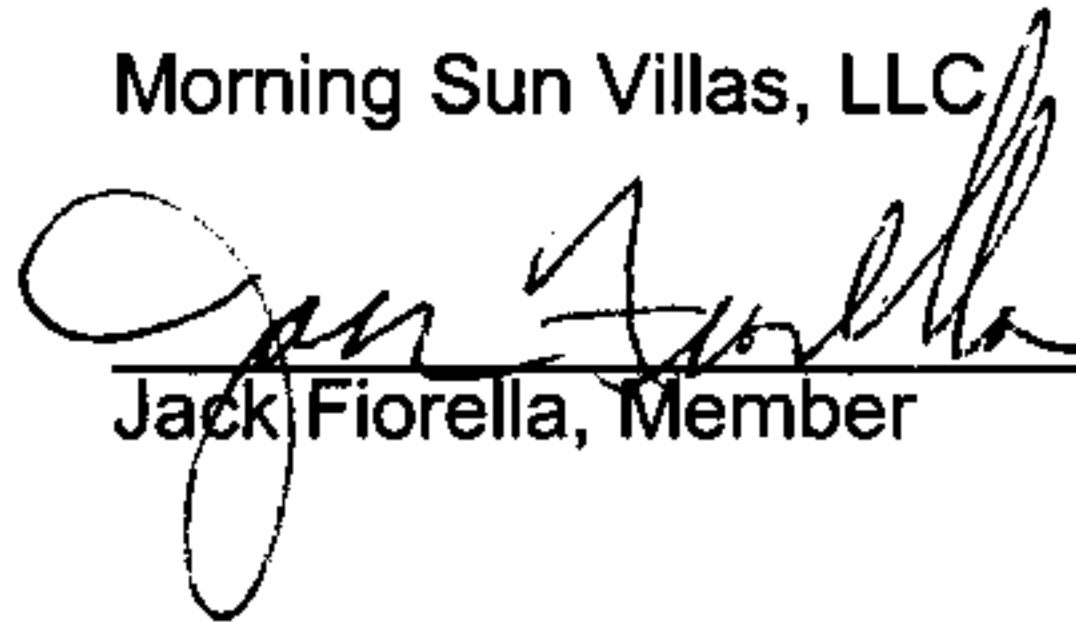

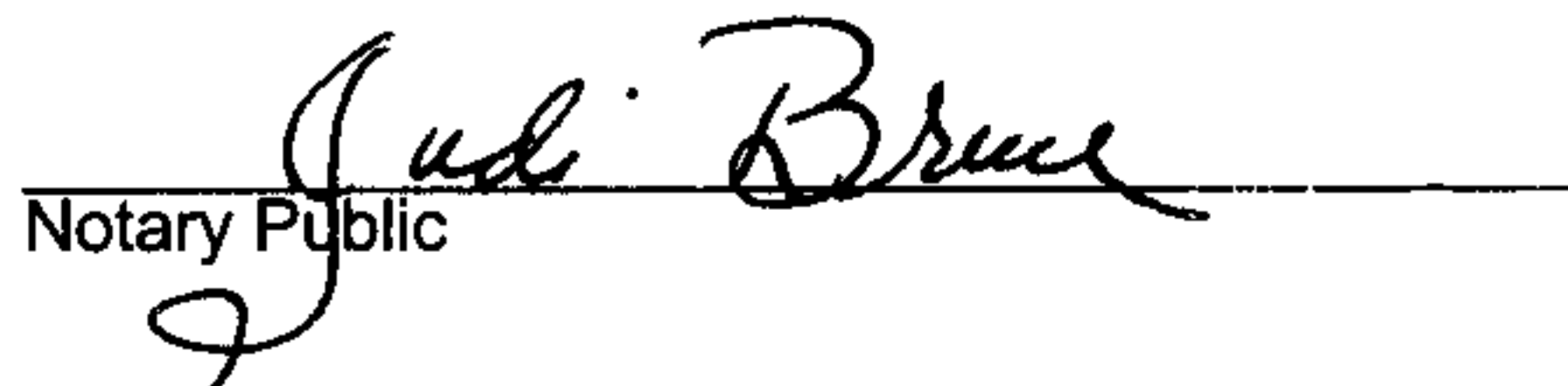
