PARTIAL RELEASE

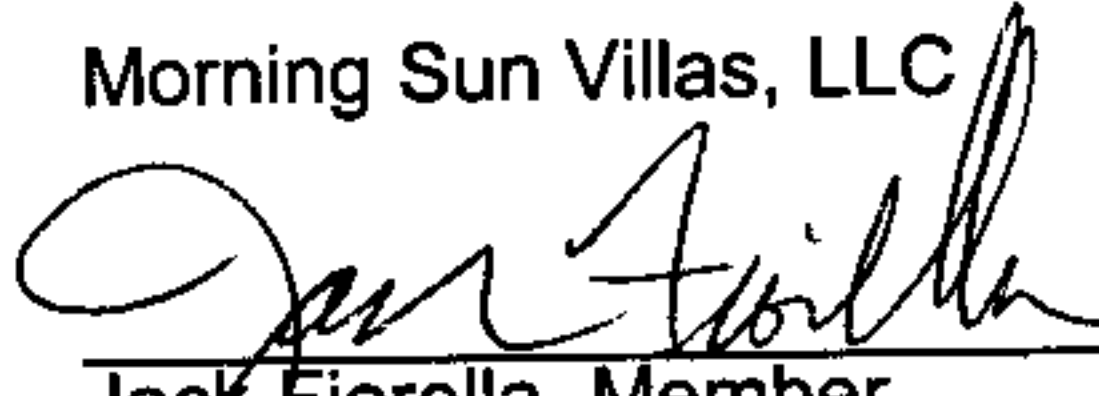

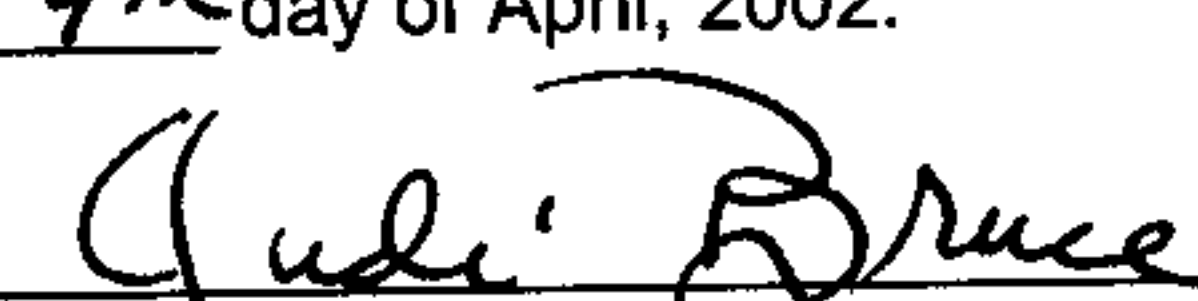
