Article I The name of the corporation: Kids First

Article II The duration of the corporation is perpetual, unless otherwise stated.

Article III

The Corporation has been organized for the following purpose(s):

To help single parent families that are not on welfare. Parents who work hard but just make enough to get by. To help with holiday's whether it is

A. No part of the net earnings of the Corporation shall inure to the benefit of any director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation),

and no officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

B. No substantial part of the activities of the corporation shall be carrying on propaganda, or other wise attempting to influence legislation (except as otherwise provided by Section (h) of the code), or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

- C.
