

Articles Of Incorporation
Of

The undersigned acting as incorporator of a corporation under the Business Corporation Act of the State of Alabama adopts the following Articles of Incorporation for such corporation:

Article I
(Name)

The name of the corporation is Alpha and Omega Services, Inc.

Article II
(Duration)

The duration of the corporation shall be "perpetual".

Article III
(Purpose)

The general purposes for which the corporation is organized are:

- (1) To engage in the business of accounting and computer consulting services,
- (2) To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business, and
- (3) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

(Capitalization)

The aggregate number of shares which the corporation is authorized to issue is \$50,000. Such shares shall be of a single class, and shall have a par value of \$100 par share.
