

**AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
STAGECOACH TRACE RESIDENTIAL ASSOCIATION, INC.**

At a special meeting on April 12, 2002, called by the President of the Board for the purpose of amending the Articles of Incorporation of Stagecoach Trace Residential Association, certain Articles are hereby amended by a vote of all members entitled to vote as follows:

**ARTICLE XIII
AMENDMENT**

For so long as Developer owns any portion of the Subject Property, with the exception of any portion of the property described in Map Book 29, Page 39, known as Stagecoach Trace, Sector 3 (hereinafter "Section 3"), these Articles of Incorporation may be amended at any time and from time to time by Developer or by the vote of the Board, without the consent or approval of any members of the Association. At such time as Developer no longer owns any portion of the Development, with the exception of Sector 3, then these Articles of Incorporation may be amended, subject to the terms and provisions of the Protective Covenants, by affirmative vote of fifty-one (51%) of the Association.

Developer may amend these Articles of Incorporation for Sector 3, only until Seventy-Five Percent (75%) of the Lots have been sold for dwelling purposes, except that the Federal Housing Administration or the Veteran's Administration shall have the right to veto the amendments so long as the Developer is the controlling member of the Lots in Sector 3. At such time that Seventy-Five Percent (75%) of the Lots have been sold, then these Articles of Incorporation may be amended, subject to the terms and provisions of the Protective Covenants, by affirmative vote of at least two-thirds (2/3) of the Lot Owners of Sector 3.
