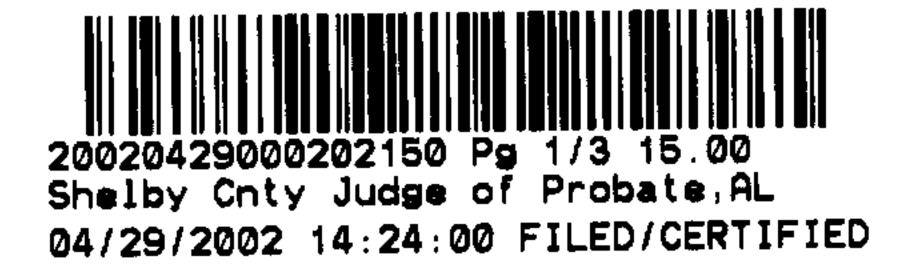
# AMENDMENT TO THE ARTICLES OF ORGANIZATION OF METRO HAULERS, LLC
