

ARTICLES OF INCORPORATION  
OF  
BANDFOLIO, INC.

THE UNDERSIGNED, being all of the Incorporators of BANDFOLIO, INC, and desiring to form a corporation pursuant to the Alabama Business Corporation Act and the general corporation laws of the State of Alabama, hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the Corporation shall be BANDFOLIO, INC

ARTICLE II

The number of directors of the initial Board of Directors shall be, three (3) and the names and addresses of the Directors chosen for the first year, and until their successors are duly elected and qualified, are as follows:

ARTICLE III

The objects and purposes for which the said Corporation is formed and the objects to be carried on and promoted by it are as follows:

(a) To transact any and all lawful business which corporations may conduct under the laws of the State of Alabama.

(b) To enter into, make and perform contracts of every kind for any lawful purpose, with any person, firm, association or corporation, town, city, county, body politic, state, territory, government or dependence thereof.

(c) To acquire, own, purchase for resale and sell, by any and all means including but not limited to direct sales, mail order sales and internet (website or e-mail) sales for cash or on credit or by use of commercial credit services such as credit card companies, PayPal and similar services, the following items and merchandise: band and other musical instruments, music scores, sheet music, and licenses to perform music as set forth on said scores and sheet music.

(d) To engage in providing, for free, or on some compensated basis, professional musical arrangements and original works to the public.

(e) To exercise every power and engage in every activity that may be necessary, appropriate, convenient and incidental to the foregoing enumerated purposes.

#### ARTICLE IV

The Corporation shall have and be invested with all rights and powers authorized by the laws and constitution of the State of Alabama, and shall have the right and power to do all things authorized by the laws of the State of Alabama as fully and to the extent as natural persons might or could do, subject only to such limitations and restrictions as are placed on corporations under and by virtue of the laws of the State of Alabama.

#### ARTICLE V

The address of the initial registered office of the Corporation shall be 103 King Valley St., Pelham, Alabama 35124 and the name of the initial registered agent at such address will be James C. Evans.

#### ARTICLE VI

(a) The Corporation shall have authority to issue One Thousand Dollars (\$1,000.00) of capital stock, which shall be divided into one thousand (1,000) shares of a par value of One and No/100 Dollars (\$1.00) per share. All such shares are of one class and are designated as common stock. Any and all such shares issued, and for which the full consideration has been paid or delivered, shall be deemed fully paid stock, and the holder of such shares shall not be liable for any further call or assessment of any other payment thereon.

(b) Every holder of the common stock of the Corporation shall have the preemptive right to purchase his proportion of the issuance of any class of stock, including treasury shares, according to the proportion of his holding of common stock, at such price, which may be in excess of par value, within such time and on such terms as shall be fixed and determined by the Board of Directors.

#### ARTICLE VII

#### ARTICLE VIII

The Corporation shall have perpetual existence.

#### ARTICLE IX

(a) The business and affairs of the Corporation shall be managed by a Board of Directors which shall be invested with all the powers and privileges provided by the laws and constitution of the State of Alabama. In furtherance, and not in limitation of said powers, the Board of Directors is expressly authorized and empowered to establish bonuses, profit sharing plans or other type of incentive or compensation plans for the employees (including officers and directors) of the Corporation, and to

fix the amounts of profits to be distributed or shared, and to determine the persons to participate in any such plans and the amount of their respective participation.

(b) Any Director or any officer may be removed at any time in such manner as shall be provided in the By-Laws of the Corporation.

(c) No contract or other transaction between the Corporation and one or more of its Directors or any other Corporation, firm, association or entity in which one or more of its Directors are directors or officers or are financially interested, shall be either void or voidable because of such relationship or interest or because such Director or directors are present at the meeting of the Board of Directors or a committee thereof which authorizes, approves or ratified such contract or transaction, if the contract or transaction is fair and reasonable to the Corporation and if either:

(1) the fact of such relationship or interest is disclosed to the Board of Directors or committee which authorizes, approves or ratifies the contract or transaction by a vote or consent sufficient for the purpose without counting the votes or consents of such interested Directors; or

(2) the fact of such relationship or interest is disclosed to the Stockholders entitled to vote and they authorize, approve, or ratify such contract or transaction by vote or written consent.

Directors with a financial interest or other conflict of interest in such a contract, matter, or other transaction may not be counted in determining the presence of a quorum at a meeting of the Board of Directors or a committee thereof which authorizes, approves, or ratifies such contract or transaction except with the unanimous prior written consent of all of the Stockholders of the Corporation.

(d) Subject to any limitation in the By-Laws, the members of the Board of Directors shall be entitled to reasonable fees, salaries, or other compensation for their services as such directors and to reimbursement for expenses incurred by them as such members. Nothing contained herein shall preclude any Director from serving the Corporation, or any subsidiary or affiliated

Corporation, in any other capacity and receiving reasonable compensation therefor.


(e) The Stockholders and Board of Directors of the Corporation shall have the power to hold their meetings, to have an office or offices, and to keep the books of the Corporation, subject to the provisions of the laws of Alabama, outside of said state and at such place or places as may from time to time be designated by them.


(f) The Board of Directors may authorize the sale and issuance of any authorized, but unissued, capital or treasury stock to such persons, on such terms and for such consideration as the Board of Directors in its discretion deems proper, provided however, existing Stockholders shall have preemptive rights to the purchase of said stock.


#### ARTICLE X

Such agreement may be entered into by any of the Stockholders or between themselves and may include the Corporation as a party thereto. A copy of any such agreement shall be retained in the principal office of the Corporation in the State of Alabama and shall be available for inspection by any Stockholder or his duly authorized agent or representative.
