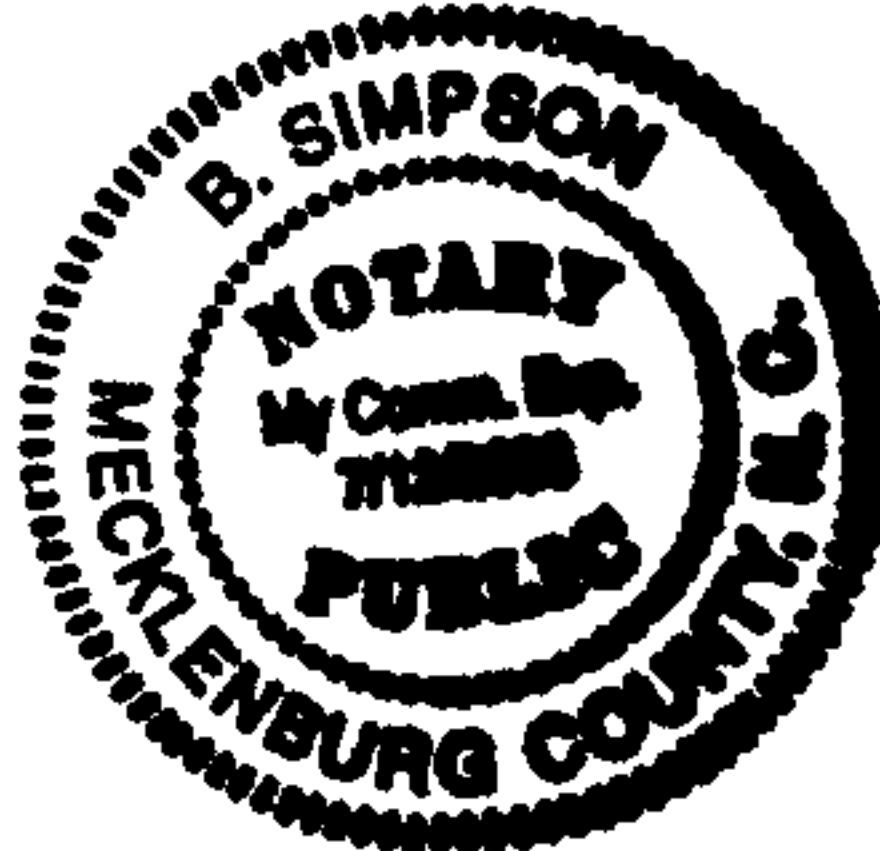

A PARCEL OF LAND IN THE S.W. 1/4 OF THE S.W. 1/4 OF SECTION 18, TOWNSHIP 20 SOUTH, RANGE 2 WEST, SHELBY COUNTY, ALABAMA; DESCRIBED AS FOLLOWS: COMMENCE AT THE SOUTHWEST CORNER OF SAID SECTION 18, THENCE RUN NORTH ALONG THE WEST LINE OF SAID SECTION 1100.24 FEET, THENCE TURN RIGHT 89 DEGREES 50 MINUTES 30 SECONDS AND RUN EAST 363.84 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE LAST COURSE 170.75 FEET TO A POINT ON THE CENTERLINE OF SHELBY COUNTY HIGHWAY #35; THENCE TURN LEFT 62 DEGREES 35 MINUTES 00 SECONDS AND RUN NORTHEAST 166.59 FEET TO A POINT ON SAID CENTERLINE, THENCE TURN LEFT 05 DEGREES 54 MINUTES 00 SECONDS AND RUN NORTHEAST 14.29 FEET TO A POINT ON SAID CENTERLINE, THENCE TURN LEFT 95 DEGREES 08 MINUTES 00 SECONDS AND RUN NORTHEAST 39.04 FEET TO THE POINT ON THE COUNTERCLOCKWISE CURVE HAVING A DELTA ANGLE OF 26 DEGREES 04 MINUTES 00 SECONDS AND A RADIUS OF 277.40 FEET, (SAID POINT BEING ON THE SOUTHERLY RIGHT OF WAY OF DOGWOOD CIRCLE), THENCE RUN ALONG THE ARC OF SAID CURVE AND THE SOUTHERLY RIGHT OF WAY OF DOGWOOD CIRCLE 126.20 FEET TO THE POINT OF A REVERSE CURVE HAVING A DELTA ANGLE OF 13 DEGREES 00 MINUTES 00 SECONDS AND A RADIUS OF 351.63 FEET, THENCE RUN ALONG THE ARC OF SAID CURVE AND THE SOUTHERLY RIGHT OF WAY OF DOGWOOD CIRCLE 80.19 FEET, THENCE TURN LEFT 90 DEGREES 00 MINUTES 00 SECONDS FROM TANGENT AND RUN SOUTH 175.41 FEET TO THE POINT OF BEGINNING.
