The above styled cause came before this Court on Plaintiff's Motion for Temporary Restraining Order or Injunction, and the Court having heard argument on same, it is hereby Ordered as follows:

- 1. Defendant, Howard Grant Dunnam, Jr. is hereby temporarily removed as Trustee of the 240 Cambrian Ridge Trail Trust at the request of Plaintiff and the Trust beneficiaries. Defendant shall conduct no business regarding Trust property until such further Order of this Court.
- 2. Intervenor, Derrick Ervin, is hereby directed to make all monthly mortgage payments which he is currently obligated to make to Mark Covin, the newly appointed Trustee of the 240 Cambrian Ridge Trail Trust at 1681 Savannah Park, Birmingham, AL 35216. Intervenor is also ordered to pay the back payments from January through the present to the Trustee. All payments are due on or before the 15<sup>th</sup> of each month.
- 3. Intervenor is further Ordered to submit to the Court by letter or memorandum, each month, evidence that each monthly payment has been made, a copy of which shall be sent to the Court file.
  - 4. Defendant, Howard Grant Dunnam, Jr. is to cooperate with the Court at all

times, and is Ordered to submit an accounting of all Trust property, funds, accounts, and monies within 30 days to counsel for the parties. Defendant is further Ordered to submit to a deposition within 30 days to counsel for the parties.
