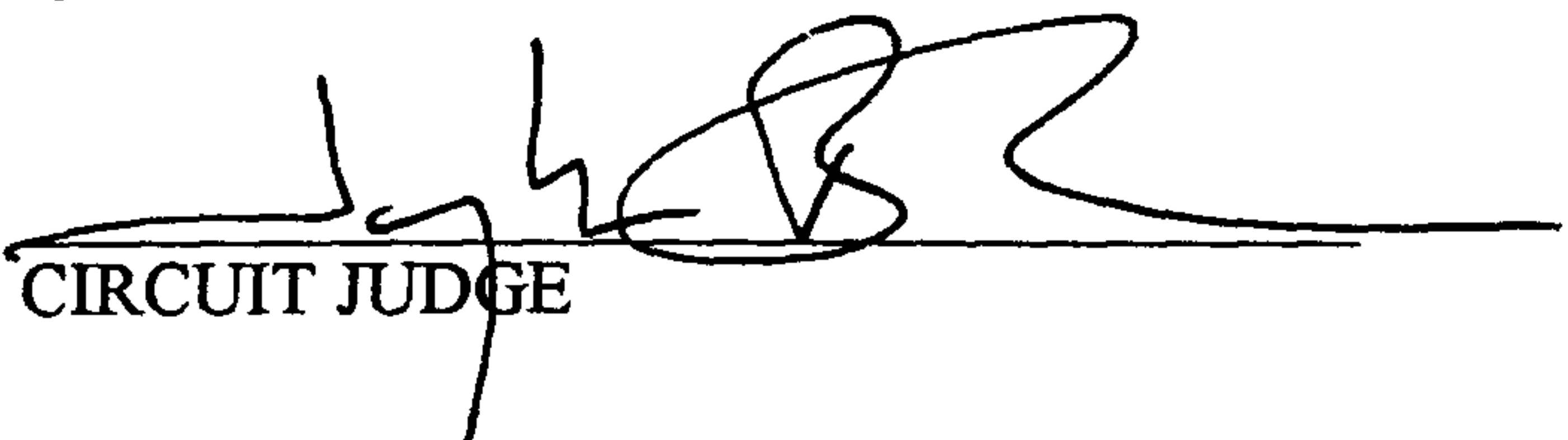
JUDGMENT AND ORDER
