RECONFIRMATION OF LIEN REINSTATEMENT OF MORTGAGE

THIS day personally appeared before me, a Notary Public in and for the State of Texas and County of Dallas, the undersigned, on behalf of First Alabama Bank nka Regions Bank, after first duly sworn, upon oath, and deposed and stated:

- John Paul Calcatera aka John Calcatera and Susan Marie Calcatera aka Susan Calcatera, (hereinafter referred to as "Mortgagor") executed a Promissory Note in the original principal sum of Fifty Thousand Dollars and 00/100 payable to First Alabama Bank (the "\$50,000.00 Note").
- 2. Said \$50,000.00 Note is secured by a Mortgage which was recorded on March 21, 1996 in the Office of the Recorder of Deeds for Shelby County, Alabama as Instrument #1996-09101, which covered the property described as follows:

- First Alabama Bank nka Regions Bank, an Alabama Corporation, erroneously executed a Discharge of Mortgage for the \$50,000.00 Mortgage. The Discharge of Mortgage dated March 6, 2002 was filed in the Office of the Recorder of Deeds for Shelby County, Alabama and was filed on March 14, 2002 as Instrument #2002-12169.

First Alabama Bank nka Regions Bank desires to reconfirm the lien and reconfirm the existence of the \$50,000.00 Mortgage as a first priority lien on the Mortgaged Property.

NOW THEREFORE, in consideration of the foregoing, First Alabama Bank nka Regions Bank, hereby asserts and affirms the following:

- 4. First Alabama Bank nka Regions Bank hereby confirms the continuing existence and validity of the first lien of the \$50,000.00 Mortgage recorded in the Office of the Recorder of Deeds for Shelby County, Alabama.
- The action taken by First Alabama Bank nka Regions Bank to discharge the \$50,000.00 Mortgage was in error and is void, no consideration having been paid by the Mortgagor for such Release.
