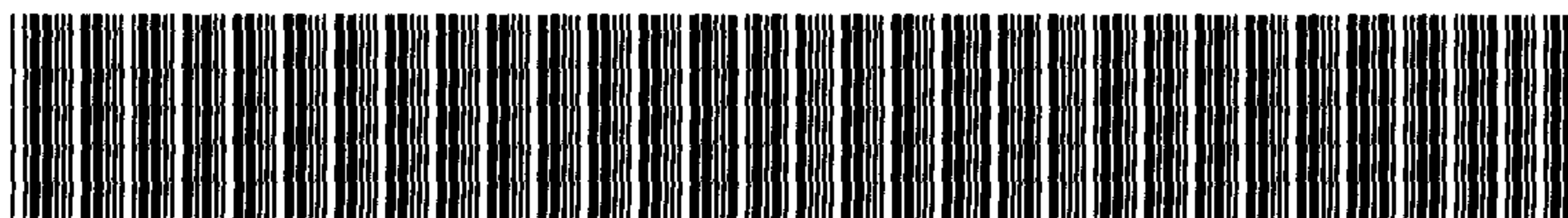

**MODIFICATION.** Lender and Grantor hereby modify the Mortgage as follows:




