

<u>CORPORATION FORM WARRANTY DEED</u> JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

<u>A Married Wman</u> (herein referred to as Grantees) as joint tenants with right of survivorship, the following described real estate, situated in <u>Shelby</u> County, Alabama, to-wit:
