Subject to:


1. Existing easements, restrictions, current taxes, set-back lines, rights of way, limitations, if any, of record.

Commence at the Southeast corner of the Northwest Quarter of the Southwest Quarter of Section 30, Township 18 South, Range 2 East, thence run North 88 degrees 06 minutes 26 seconds West for 912.39 feet, thence run North 17 degrees 48 minutes 05 seconds East for 262.0 feet to the point of beginning, thence run South 88 degrees 06 minutes 26 seconds East for 8.15 feet; thence run North 30 degrees 53 minutes 37 seconds East for 190.35 feet, thence run North 80 degrees 30 minutes 37 seconds West for 258.57 feet to the East right of way line of Shelby County Highway No. 55, thence run Southwesterly along said road right of way line for 190 feet to a point, thence run South 88 degrees 06 minutes 26 seconds East for 210 feet, more or less, to the point of beginning.
