ADMINISTRATOR'S DEED

This deed made this 31<sup>st</sup> day of May, 2002, between William Harris Crotwell, of the County of Tuscaloosa, State of Alabama, as Administrator of the Estate of Alex Harrison Crotwell, Deceased, late of Tuscaloosa County, Alabama, hereinafter referred to as "Administrator", and William Harris Crotwell and Lynette Crotwell, of the State of Alabama, hereinafter referred to as Grantees, witnesseth:

WHEREAS, Alex Harrison Crotwell, died on or about the 13<sup>th</sup> day of October, 2000;  
and

WHEREAS, William Harris Crotwell was duly re-appointed Administrator of the Estate of Alex Harrison Crotwell, Deceased, on or about the 22<sup>nd</sup> day of May, 2002, by the Probate Court for the County of Tuscaloosa, State of Alabama; and

WHEREAS, William Harris Crotwell, as Administrator of the Estate of Alex Harrison Crotwell, Deceased, holds the title to real estate previously held by said Alex Harrison Crotwell, Deceased.



Together with all and singular the hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and all the estate, right, title, interest, claim and demand whatsoever, at law or in equity, which, Alex Harrison Crotwell, deceased, had at the time of his death in and to the said premises.

To have and to hold the same unto the Grantees, their heirs and assigns forever, as fully and effectually to all intents and purposes in law as Administrator might, could or ought to sell and convey the same by virtue of the said decretal order of the Probate Court, above referred to.


