JUDGMENT

This matter having come before the Court on the Summons and Complaint filed against the Defendants herein and the Defendants having been duly served with the Complaint and the Defendants having executed a Consent to Judgment herein, it is therefore ORDERED, ADJUDGED and DECREED as follows:

1. That judgment is hereby entered against both Defendants in favor of the Plaintiff in the sum of Six Thousand Two Hundred Sixty-Four Dollars (\$6,264.00). This amount includes past due rent, late charges, attorney's fees and cost of court.

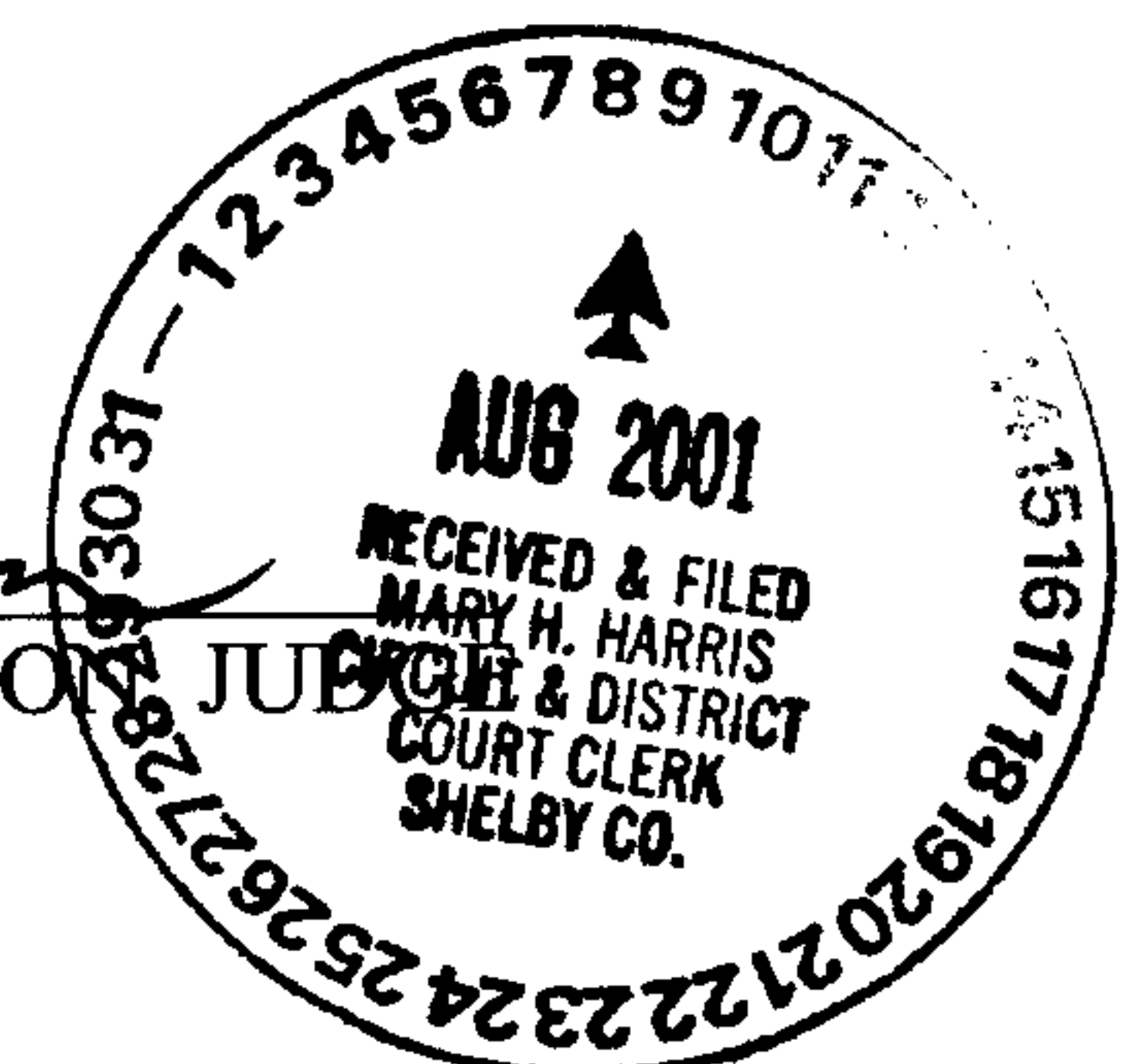
2. The Defendants shall be allowed to satisfy this judgment (along with the continuing interest thereon) at the rate of Two Hundred and No/100th Dollars (\$200.00) per month commencing August 1, 2001.

3. The Defendants have also consented and it is hereby ordered that the Defendants shall make their future monthly rental payments on a timely basis. Should the Defendants be more than ten (10) days late with their monthly rental payment or with the payment of this judgment, then the entire amount of said judgment shall be due and payable immediately. In addition, the Defendants have consented and the Court specifically orders that should the Defendants default in the terms of this judgment, the Court will upon written request from Plaintiff's attorney, immediately enter an order directing the Sheriff of Shelby County to evict the Defendants.

4. Costs of court are hereby taxed as paid.
