Know All Men by These Presents: That in consideration of **One hundred forty nine thousand five hundred forty five and no/100 (\$149,545.00)** to the undersigned grantor **Wiggins Building Corporation**, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Wiggins Building Corporation** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Jeremy L. Head and Marti W. Head** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.


\$147,225.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.
