Know All Men by These Presents: That in consideration of **Ninety eight thousand and no/100 (\$98,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Ashley Hollowell and Caroline M. Hollowell, husband and wife and Sharon Spragins, a married woman** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Burma Blount Hamby and Warren C. Hamby, Jr. and Warren C. Hamby, Sr.** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:


