Articles of Incorporation

Pursuant to the provisions of the Alabama Business Corporations Act, the undersigned hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation is:
Alabama Endodontics, PC

Article II

The duration of the corporation is perpetual

Article III

The corporation has been organized for the following purposes:
To provide professional dentistry services with an emphasis on endodontic care and to transact any or all lawful business for which corporations may be incorporated under this chapter.

Article IV

This corporation is incorporated under the Professional Corporation laws of the State of Alabama.

Article V

The number of shares which the corporation shall have the authority to issue is five thousand (5,000) and the par value of each share shall be one dollar (\$1.00) for a total authorized capital of Five Thousand and no/100's dollars (\$5,000.00).

Article VI

Not less than all of the shares entitled to vote, represented in person or by proxy shall constitute a quorum at a meeting of the shareholders. Each outstanding share shall be entitled to one vote on each issue submitted to a vote at a meeting of the shareholders. Except as otherwise required by law, the majority of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholder. All shareholders of the

corporation shall be duly licensed to practice dentistry in Alabama.
