Parcel No. 3 of "A Resurvey of Pool's Addition to Pelham", in the NW 1/4 of the NE 1/4 of Section 2, Township 20 South, Range 3 West, described as follows:

Commence at the Northeast corner of the Northwest 1/4 of the Northeast 1/4 of Section 2, Township 20 South, Range 3 West, Shelby County, Alabama, and run thence Southerly along the East line of said 1/4-1/4 a distance of 515.15 feet to the point of beginning of the property being described; thence turn an angle of 90 degrees 00 minutes 00 seconds right and run Westerly a distance of 136.35 feet to a point on the East right of way line of Aaron Road in a curve to the right having a central angle of 8 degrees 55 minutes 12 seconds and a radius of 778.20 feet; thence turn an angle of 84 degrees 35 minutes 47 seconds left to chord and run a distance of 121.15 feet to the P. T. of said curve; thence continue along the tangent of said curve a tangent distance of 25.0 feet to the P.
