



EXHIBIT "A"

Begin at the Common Front Lot corner of Lot 130 and Lot 131, Lake Forest, First Sector, as recorded in Map Book 24, Page 62, Shelby County, Alabama; thence run Northwesterly along said common lot line for a distance of 40.00 feet to a point; thence turn an angle to the right at 167° 16' 58" and run Southeasterly for 40.88 feet, more or less; to a point on the Westerly right of way of Sugarberry Drive, said point being on a curve having a radius of 325.00 feet, a central angle of 01° 35' 12" and curving to the right in a Southwesterly to Westerly direction; thence run along the arc of said curve right of way for an arc distance of 9.00 feet to the point of beginning; being situated in Shelby County, Alabama.
