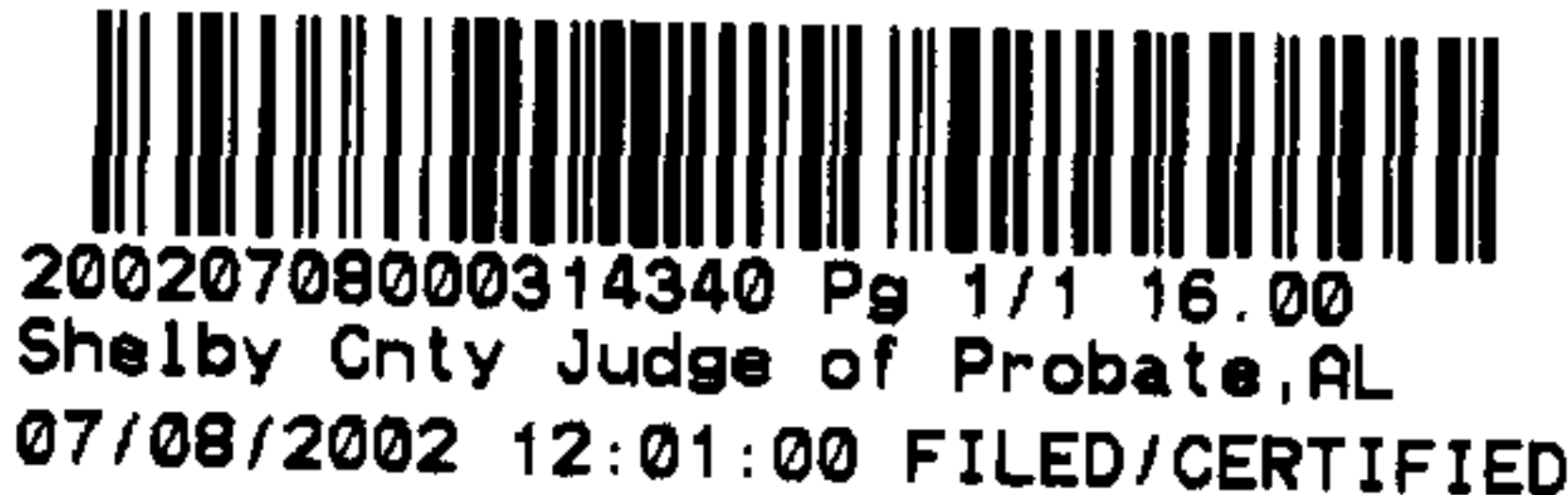

KNOW ALL MEN BY THESE PRESENTS,



That in consideration of **ONE DOLLAR (\$1.00) AND OTHER GOOD AND VALUABLE CONSIDERATION** to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **The Estate of Loyd V. Harris, deceased, by and through its Co-Personal Representatives, Tamara M. Harris (formerly known as Tamara Harris Jackson and Tamara Michelle Harris Frye Jackson) and Ricky Lloyd Harris,** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Tamara M. Harris,** (herein referred to as Grantee, whether one or more), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

A parcel of land situated in Section 4, Township 22 South, Range 3 West, Shelby County, Alabama, more particularly described as follows: **Begin at the intersection of the north right-of-way of County Road No. 22 and the west line of Section 4; thence proceed north 170'; thence proceed east 22.24'; thence proceed southeasterly 180.61' to the north right-of-way of County Road No. 22; thence proceed west along said right-of-way for 72.93', to the point of beginning.**

THIS DEED OF CONVEYANCE IS MADE PURSUANT TO LETTERS TESTAMENTARY REGARDING THE ESTATE OF LOYD V. CLIFFORTINE KIRKLEY HARRIS (A/K/A CLIFFORTINE K. HARRIS), THE WIFE OF LOYD V. HARRIS, WHO PREDECEASED HIM, WAS THE OWNER AND RECORD TITLE HOLDER OF THE ABOVE DESCRIBED PROPERTY UPON THE DATE OF HER DECEASED. CONSEQUENTLY, REFERENCE IS HEREBY MADE TO INSTRUMENT #1999-41549, AS RECORDED IN THE OFFICE OF THE PROBATE JUDGE OF SHELBY COUNTY, ALABAMA, SAME CONSTITUTING AN AFFIDAVIT AS TO HEIRS AND DEVOLUTION.

And I (we) do, for myself (ourselves) and for my (our) heirs, executors and administrators covenant with the said grantee, his, her or their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise stated above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said grantee, his, her or their heirs and assigns forever, against the lawful claims of all persons.
