

ARTICLES OF ORGANIZATION OF CHECK EXCHANGE MOBILE LLC, LIMITED LIABILITY COMPANY/LLC

Pursuant to the Provisions of Sections 10-12-1, *et seq*. of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

The name of the limited liability company is CHECK EXCHANGE MOBILE, Limited Liability Company/LLC. (The "Company").

ARTICLE II

Duration

The Company shall have a perpetual duration from the date of organization in perpetuity unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act:).

ARTICLE III

Purposes

The purpose for which the Company is formed are:

- (a) Provide dialup internet service and internet cafe to the general public;
- (b) To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative, accounting, bookkeeping and other services of every nature, kind, and character, which it may legally render;
- (c) To engage in any other lawful business of any kind or character whatsoever;

ARTICLE IV
