WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,
Michael P. Warsaw and wife, Jacqueline J. Leary-Warsaw

(herein referred to as grantors) do grant, bargain, sell and convey unto Jeff Nichols and wife, Sherrie Nichols

(herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in
Shelby County, Alabama to-wit:

administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
