Commence at the SW corner of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 7, Township 20 South, Range 1 West, thence South $89^{\circ}06'28''$ East, a distance of 448.89 feet; thence North $02^{\circ}10'55''$ East, a distance of 148.41 feet; thence North $02^{\circ}10'55''$ East a distance of 148.41 feet to the point of beginning; thence South $72^{\circ}19'44''$ East a distance of 276.05 feet; thence South $06^{\circ}32'31''$ East a distance of 65.78 feet; thence South $83^{\circ}31'09''$ East a distance of 213.69 feet; thence South $20^{\circ}56'11''$ West a distance of 48.54 feet; thence South $09^{\circ}57'12''$ East a distance of 91.61 feet; thence North $77^{\circ}14'06''$ East a distance of 17.17 feet; thence South $14^{\circ}20'16''$ East a distance of 149.22 feet; thence South $42^{\circ}16'47''$ East a distance of 54.47 feet; thence South $12^{\circ}20'05''$ East a distance of 318.74 feet; thence North $51^{\circ}26'42''$ East a distance of 93.23 feet; thence North $66^{\circ}55'57''$ East a distance of 139.44 feet; thence North $02^{\circ}39'55''$ East a distance of 529.43 feet; thence North $02^{\circ}35'14''$ East a distance of 1,202.93 feet; thence North $71^{\circ}01'55''$ West a distance of 2.22 feet to a point, said point lying on the Southerly ROW line of Shelby County Road #336 (Prescriptive ROW), said point also being the beginning of a non tangent curve to the left, having a radius of 960.94 feet, a central angle of $05^{\circ}59'54''$ and subtended by a chord which bears South $06^{\circ}17'36''$ West and a chord distance of 100.56 feet; thence along the arc of said curve and said ROW line, a distance of 100.60 feet; thence South $01^{\circ}41'12''$ West and along said ROW line, a distance of 209.48 feet to a point, said point being the beginning of a non tangent curve to the right, having a radius of 368.21 feet, a central angle of $65^{\circ}19'18''$, and subtended by a chord which bears South $32^{\circ}42'00''$ West, and a chord distance of 397.42 feet; thence along the arc of said curve and said ROW line a distance of 419.79 feet to a point, said point being the beginning of a compound curve, having a radius of 1853.78 feet, a central angle of $03^{\circ}29'22''$, and subtended by a chord which bears South $68^{\circ}28'06''$ West, and a chord distance of 112.88 feet; thence along the arc of said curve and said ROW line, a distance of 112.90 feet to a point, said point being the beginning of a compound curve, having a radius of 1853.78 feet, a central angle of $06^{\circ}27'23''$, and subtended by a chord which bears South $73^{\circ}26'29''$ West and a chord distance of 208.79 feet; thence along the arc of said curve and said ROW line a distance of 208.90 feet; thence South $76^{\circ}00'11''$ West and along said ROW line, a distance of 386.54 feet; thence South $02^{\circ}10'55''$ West and leaving said ROW line, a distance of 202.46 feet to the point of beginning.
