For-Profit Corporation Articles of Incorporation

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

- Article I** The name of the corporation is **Chandler Financial Group, Inc.**
- Article II** The duration of the corporation is perpetual.
- Article III** This corporation has been organized for the following purpose:
To own, operate, conduct, maintain, and carry on the business of sales and marketing of the products of various companies, including financial products and services in the State of Alabama and the transaction of any and/or all lawful business for which corporations may be incorporated under this chapter.
- Article IV** The number of shares, which the corporation shall have authority to issue, is Ten Thousand (10,000) and the par value of each share shall be one cent (0.01). If the shares are to be without par value, then "no par value" shall be stated.
- Article V** The street address of the registered office is 1413 Whirlaway Court, Helena, Alabama 35080, and the name of the registered agent at that office is Cindy M. Chandler.
