

ORDINANCE NO. 599-02

AN ORDINANCE DE-ANNEXING CERTAIN PROPERTY FROM THE CITY OF HELENA

BE IT ORDAINED by the City Council of the City of Helena, Alabama, in regular meeting duly assembled, a quorum being present, as follows:

Section 1. Whereas a petition signed by RiverWoods Properties, LLC, has been presented to the City Clerk of the City of Helena, copy of which is attached hereto and marked as Exhibit "A", requesting the property described therein be de-annexed from the City of Helena, said property being situated in Shelby County, Alabama, and described as follows:

- Section 2. The City Council of the City of Helena hereby finds that said above described property was heretofore annexed into the city limits of the City of Helena and should now be deannexed, and that it is in the best interest of the City of Helena that said property be de-annexed.
- Section 3. That the City of Helena does hereby assent to the de-annexation of said property from the City of Helena, Alabama, and said property should be and the same is hereby de-annexed from the City of Helena, Alabama.
- Section 4. That the City Clerk shall file a certified copy of this Ordinance containing an accurate description of said de-annexed property with the Probate Judge of Shelby County, Alabama, and shall also cause a copy of this Ordinance to be published by posting at three (3) public places in the City of Helena, and otherwise as provided by law.


LEGAL DESCRIPTION
