Shelby County

Begin at a point where the South line of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 5, Township 22 South, Range 1 East intersects the East side of the right of way of Montgomery Road; thence run Northeasterly along the East right of way line of said road 990 feet to a point; thence run Southeasterly to a point on the South line of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 5, which point is 2044 feet East of the point of beginning and which point is marked by a stub in the center of old Good Hope Road; thence run West along the South line of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$, the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ and the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$, all in said Section 5, a distance of 2044 feet to the point of beginning.
