ARTICLES OF INCORPORATION OF AIRPORT VETERINARY HOSPITAL, P.C.

The undersigned, who is a duly licensed Doctor of Veterinary Medicine, in the State of Alabama, desiring to form a professional corporation in accordance with the Alabama Business Corporation Act and the Revised Alabama Professional Corporation Act, adopt the following Articles of Incorporation:

I. NAME

The name of the Professional Corporation is Airport Veterinary Hospital, P.C.

II. PURPOSE

The purpose for which the Corporation is organized is to practice the profession of veterinary medicine.

III. ELECTION UNDER PROFESSIONAL CORPORATION ACT

The Corporation elects to be governed by the provisions of the Revised Alabama Professional Corporation Act.

IV. DURATION

The term of existence of the Corporation is perpetual.

V. CAPITAL STOCK

The number of shares the Corporation is authorized to issue is One Thousand (1,000), all of which shall be common shares with par value of \$ 1.00.

VI. STATED CAPITAL

The amount of capital with which the Corporation shall begin business is \$1,000.00.

VII. REGISTERED OFFICE
