## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

## KNOW ALL MEN BY THESE PRESENTS:

That in consideration of Eighty Seven Thousand Dollars (\$87,000.00) to the undersigned Grantors in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, John F. Wood and wife, Lyne S. Wood, (hereinafter referred to as Grantors) hereby grant, bargain, sell and convey unto Stanley B. Ennis and wife, Johnnie S. Ennis (hereinafter referred to as Grantees) as joint tenants with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 8, according to the Survey of Walters Cove, First Sector, as shown by subdivision map recorded in Map Book 5, page 22, in the Probate Office of Shelby County, Alabama. Situated in Shelby County, Alabama.

Subject to current taxes due but not yet payable. Subject to easements and restrictions of record.

This is not the home place of the Grantors.

TO HAVE AND TO HOLD unto the said Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do for ourselves and for our heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that it is free from all encumbrances unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; and we will and our heirs, executors, and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever.
