## NON-EXCLUSIVE RIGHT OF WAY OR EASEMENT FOR INGRESS, EGRESS AND UTILITIES

An easement for ingress and egress over and across the following described property: Begin at the NE corner of the SE 1/4 of the SW 1/4 of Section 9, Township 24 North, Range 12 East, Shelby County, Alabama; thence S 00 degrees 12 minutes 49 seconds E 174.98 feet to the point of beginning; thence S 79 degrees 59 minutes 05 seconds E 48.26 feet; thence N 03 degrees 07 minutes 23 seconds E 30.00 feet; thence N 80 degrees 16 minutes 58 seconds W 49.99 feet; thence S 00 degrees 12 minutes 49 seconds E 30.0 feet to the point of beginning.

Together with:

An easement 15 feet wide with the center line being described as follows: commence at the NE corner of the dominant tenement; thence run N 88 degrees 51 minutes 45 seconds W 30.0 feet to the point of beginning, thence N 75 feet 00 minutes E 75.0 feet; thence N 15 degrees 05 minutes 25 seconds W 181.15 feet; thence N 19 degrees 58 minutes 39 seconds E 235.32 feet; thence 71 degrees 45 minutes 03 seconds E 117.45 feet; thence S 71 degrees 34 minutes 25 seconds E 112.55 feet; thence S 61 degrees 59 minutes 10 seconds E 76.34 feet to the Westerly right of way of Shelby County Road No. 73.
