**ARTICLES OF INCORPORATION
OF
CROWN BUILDING MAINTENANCE INCORPORATED**

The undersigned, acting as an incorporator of a corporation under the Code of Alabama, adopt the Articles of Incorporation for such corporation;

ONE

The name of the corporation shall be Crown Building Maintenance Incorporated.

TWO

The period of its duration is perpetual.

THREE

The purpose or purposes for which this corporation is formed are:

1. To generally engage in the business of building maintenance providing services connected with building maintenance and all things in any way connected with the field or area of building maintenance.
2. To transact the business of building maintenance for hire, or under contract, or upon commission or otherwise, by and through the means of consulting, advising, managing, supervising, organizing and/or contracting or rented leasing, and services.
3. To advise, instruct, assist, supervise and render all services of every kind and description in the field of building maintenance.

4. To transact any lawful business for which corporations may be incorporated under the Alabama Business Corporation Act.

5. To purchase, acquire, hold and prove, sell, convey, assign, release, mortgage, encumber, leases, hire and deal in real and personal property of every name and nature including stocks and securities of the corporations and to loan money and take securities for the payment of all sums due to corporation and to sell, assign and release such securities. To build, erect, construct, lease or otherwise acquire dwelling houses, apartment houses, office building and land, and to sell, assign and release such securities. To build, erect, construct, lease or otherwise acquire dwelling houses, apartment houses, office buildings and lands, and to sell, lease or otherwise dispose of the same.

6. This corporation shall have the power to make loans on mortgages secured by each estate and to do all things incidental to or in furtherance of the ownership, collection and liquidation of such loans.

7. This corporation shall have the power to purchase, acquire, seek, dispose of and otherwise deal in negotiable and non-negotiable instruments of all kinds, whether secured by mortgage or otherwise, and to do all things incidental to or in furtherance of the ownership and liquidation of such items.

8. This corporation shall have the power to acquire all and any of the goodwill, rights, property and business of any person, any manner dispose of the whole or any of the rights property and business so acquired and to assume in connection therewith any liabilities of such person, firms, corporation or association.

9. This corporation shall have the right and power to borrow money for any of the purposes of the corporation and to issue bonds, debentures, notes or other obligations of any nature and in any manner permitted by law for money so borrowed or in payment for property purchased, or for any other lawful consideration and to secure the payment thereof and of the interest thereon by mortgage upon or pledged, conveyance or assignment in trust of the whole or assignment in trust of the personal, including contract rights, whether at the time owned or thereafter acquired, and to sell, place, discount or otherwise dispose of such bonds, notes or other obligations of the corporation for its corporation purpose.

10. To lend money and to borrow money and to give or take security therefore by way or mortgage, pledge, transfer or assignment of real or personal property of every nature and description.

11. This corporation shall have power and right to carry on in general any other business in connection with the foregoing, not prohibited by law, and to have and exercise all powers conferred by the State of Alabama on corporations generally.

FOUR

The aggregate number of shares which the corporation shall have the authority to issue is One Hundred (100.00) shares at a par value of One Dollar (\$1.00) per share.

FIVE

Provisions for the regulation of the internal affairs of the corporation are as provided in the Bylaws.

SIX

The address of the initial registered office of the corporation is 632 Park Forest Lane, Montevallo, Alabama 35115 and the name of its initial registered agent at such address is Bruce Durrett.

SEVEN

The number of directors constitute the initial board of directors of the corporation is one and the name and address of the persons who are to serve as directors until the first meeting of shareholders or until their successors are elected and shall qualify are:


NINE

No contract or other transaction between the corporation and any other corporation and no act of this corporation shall in any way be affected or invalidated by the fact that any of the officers or directors of this corporation are pecuniarily or otherwise interested in or are directors or officers of such other corporation. Any directors individually or any firm of which any directors may be a member may be a part to or may be pecuniarily or otherwise interested in any contract or transaction of this corporation and any director of this corporation who is also a director or officer of such corporation or is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of his corporation which shall authorize any such contract or transaction with like force and effect as if he were not such director or officer of such other corporation or not so interested.

TEN

No stockholder of the corporation shall, because of his ownership of stock, have a pre-emptive or other right to purchase, subscriber or take any part of any stock, or any part of the notes, debentures, bonds or other securities convertible into or carrying option warrants to purchase stock of the corporation authorized by this Certificate of Incorporation, or by an amended Certificate duly filed, may at any time be issued, optioned for sale and sold or disposed of by the corporation pursuant to resolution of its Board of Directors to such person and upon such terms as may such board seem proper without first offering such stock or securities or any part thereof to existing stockholders.

THE UNDERSIGNED, being the Incorporators hereinabove name, for the purpose of forming a corporation pursuant to the Alabama Business Corporation Act, have executed the foregoing article of Incorporation on this the 2nd day of May, 2002.




