Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:


First: The name of the corporation is Mountainview Church of Christ, Inc.


Second: The following amendment of the Articles of Incorporation was adopted in the manner provided by the Alabama Business Corporation Act:




