

ORDERED AND ADJUDGED:

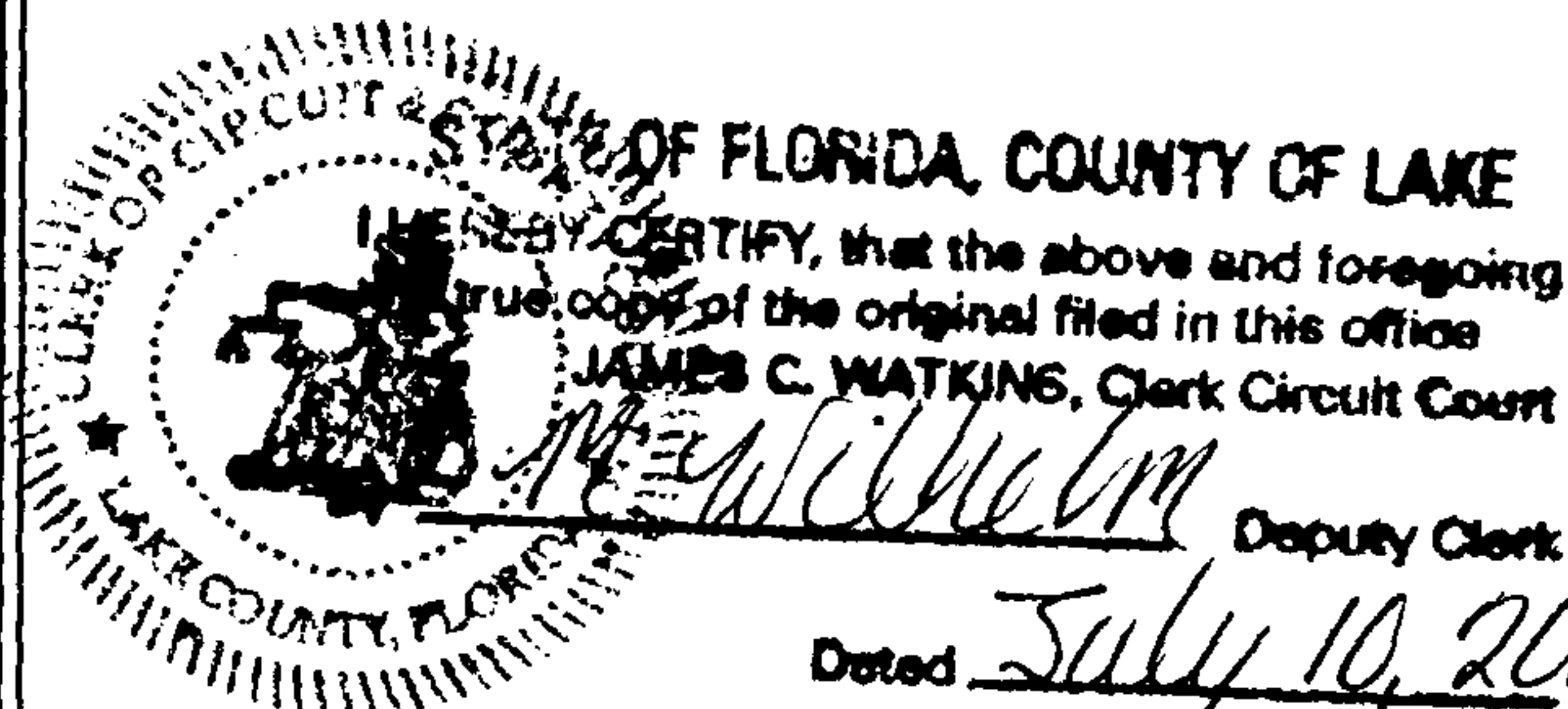
1. Plaintiff, HENRY HODDE, shall recover from the Defendants, JOHN BRILL and WESLEY MORRIS, the following sums:
