


**AFFIDAVIT IN SUPPORT OF ENFORCEMENT





This action was heard on Plaintiff's Motion for Summary Judgment and Award of Attorney's Fees, and the Court having reviewed the pleadings, heard arguments of counsel and being otherwise duly advised in the premises, it is

**ORDERED AND ADJUDGED:**

1. As to Count I, Plaintiff, HENRY HODDE, shall recover jointly and severally from the Defendants, TAMARINA, INC., WESLEY MORRIS, and JOHN BRILL, the following sums:

2. As to Count II, Plaintiff, HENRY HODDE, shall recover from the Defendant, WESLEY MORRIS, the following sums:
