That in consideration of One Hundred Eighty Three Thousand Nine Hundred Ninety Two and No/100 (\$183,992.00) Dollars to the undersigned grantor, **NSH CORP.**, a corporation, (herein referred to as GRANTOR) in hand paid by the grantee herein, the receipt whereof is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto **CONSTANTINE J. PIHAKIS** and wife, **JENNIFER L. PIHAKIS**, (herein referred to as Grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:


