## MORTGAGE SUBORDINATION AGREEMENT

This Agreement Made in the City of Tuscaloosa, County of Tuscaloosa, State of Alabama, on this the 24th day of JULY, 2002 by and between First Federal Bank, and BROOKE T. LOTT AND WIFE, CINDY C. LOTT.

Whereas **BROOKE T. LOTT AND CINDY C. LOTT,** as owners of the following described real property located in **SHELBY** County, Alabama, to-wit:

mortgage), pro	vided all such advances do not exceed the sum of \$151200.00.

That this Agreement shall be binding upon and secure the parties hereto and their respective heirs, legal representatives, successors and assigns, and shall inure to the benefit of First Federal Bank, it's successors and assigns.
