Know All Men by These Presents: That in consideration of TWO HUNDRED FIFTY THOUSAND TWO HUNDRED TWENTY FOUR DOLLARS and 00/100 (\$250,224.00) to the undersigned grantor, UNITED HOMEBUILDERS, INC. in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR, does by these presents, grant, bargain, sell and convey unto JOHN P. GOGAN and SUZIE M. GOGAN, HUSBAND AND WIFE, (herein referred to as GRANTEES, as joint tenants, with right of survivorship, whether one or more) the following described real estate, situated in SHELBY County, Alabama, to-wit:


